A meeting of the Board of Directors of Cameron County Drainage District No. 3 convened on March 11, 2024, at 2:00 p.m. at the office of the District, pursuant to notice duly given as required by law. Present were Ronaldo Garcia and Matthew McCarthy, Directors; Craig M. Harmon, General Manager; Freddie Ortega, Drain Supervisor; Jack Brown, Engineer; and B. R. Dossett, Attorney. President Garcia called the meeting to order and presided.

1. Minutes.

- 1.1 The Minutes of the January 15, 2024 meeting were presented and reviewed. The motion was made and seconded that the Minutes of the January 15, 2024 meeting be approved. Following a discussion, the motion carried.
- 1.2 The Minutes of the February 11, 2024 meeting were presented and reviewed. The motion was made and seconded that the Minutes of the February 11, 2024 meeting be approved. Following a discussion, the motion carried.
- 2. Public Comment Period. No one appeared. No written comments were received.

3. Subdivisions.

- 3.1 Paso Real Coves Subdivision, Phase II, being 12.76 acres out of Block 146, San Benito Land & Water Company Subdivision. Owner: HDP Paso Real, LLC. Plat Preparer: Melden & Hunt, Inc. General Manager Harmon reported that the plat having been given preliminary approval at the February 12, 2024 meeting, no license agreement being required, and the final plat (mylar) having been submitted without any changes, he signed the final plat on February 21, 2024. It was noted that the General Manager has been authorized to sign final plats when there have been no changes to the preliminary plat and all conditions have been satisfied. The motion was made and seconded that the signing of the plat by Manager Harmon be ratified. Following a discussion, the motion carried.
- 7-Eleven US 77 Subdivision, being 2.62 acres out of Block 130, San Benito Land & Water Company Subdivision. Proposed plat reviewed; final plat (mylar) not submitted. It was noted that there are no District drains in the subject property. The motion was made and seconded that the plat of 7-Eleven US 77 Subdivision be given preliminary approval. Following a discussion, the motion carried.
- 3.3 San Sebastian Estates Subdivision, being 5.0 acres out of Block 253, San Benito Irrigated Land Company Subdivision. Proposed plat reviewed; final plat (mylar) not submitted. It was noted that there are no District drains in the subject property, and it had been given preliminary approval at the November 24, 2022 meeting. The motion was made and seconded that the plat of San Sebastian Estates be given preliminary approval. Following a discussion, the motion carried.
- 3.4 Comperos No. 1 Subdivision, being 10.0 acres out of Block 123, San Benito Land & Water Company Subdivision. Proposed plat reviewed; final plat (mylar) not submitted. It was noted that there are no District drains in the subject property. The motion was made and seconded that the plat of Comperos No. 1 Subdivision be given preliminary approval. Following a discussion, the motion carried.
- 3.5 Rio Delta Subdivision, being 49.02 acres out of Blocks 12 and 13, James Dickinson Subdivision of Partition Shares 13 & 14 [Volume 4, Page 22, Map Records]. Proposed plat reviewed; final plat (mylar) not submitted. It was noted that there are no District drains in the subject property. The motion was made and seconded that the plat of Rio Delta Subdivision be given preliminary approval. Following a discussion, the motion carried.
- 3.6 Cielo Grande Subdivision, being 13.39 acres out of Blocks 107 and 108, San Benito

Irrigation Company Subdivision. Proposed plat reviewed. It was noted that this plat was not approved at the May 12, 2023 meeting [Minute Book 9, Page 455, Agenda Item 3.1], "the reasons for this action to be stated in writing in a letter sent to the applicant. . " and the problems identified in the letter have not been corrected. The motion was made and seconded that approval of the plat of Cielo Grande Subdivision be denied. Following a discussion, the motion carried.

- 4. Audit: Audit of Fiscal Year Ended September 30, 2023. The auditor has commenced the audit.
- 5. Annexation of Territory and Donation of Drains in Share 22, Espiritu Santo Grant.
 - 5.1 Annexation. Yountville Holdings, LLC did not present a petition for annexation. No action.
 - 5.2 Donation. Yountville Holdings, LLC did not present a deed conveying drains to the District. No action.
- 6. Equipment.
 - 6.1 Brushcutters Purchased at October 16, 2023 Meeting. Not yet delivered. The dealer says the machines are in transit.
 - 6.2 Disposal of Surplus Equipment. The District has not yet disposed of any machines declared as surplus at the January and February 2024 meetings.
 - 6.3 Dozer Purchased at October 16, 2023 Meeting. Not yet delivered. Request of Cameron County Irrigation District No. 2 that instead of trading in the 2012 D6K Dozer, it be sold to the Irrigation District, the sales price being the trade-in amount. The motion was made and seconded that the 2012 D6K Dozer not be traded in and instead be declared surplus, and sold to Cameron County Irrigation District No. 2 for the trade-in amount. Following a discussion, the motion carried.
 - Backhoe. The Board directed General Manager Harmon to solicit bids for a new backhoe for the Board's consideration at the April 2024 meeting.
- 7. Rancho Grande Diversion Project/Drain A Bypass Extension to River–Installation of Structure at Outfall. Manager Harman obtained the needed water surface elevation data. Engineer Brown reported that preparation of the recommendations is in progress.
- 8. Projects.
 - 8.1 East Line Drain Relief Project 2012. No report.
 - 8.2 Drain B-2: Upgrade of Pennsylvania Boulevard Road Crossing. The City of San Benito has completed the rerouting of the sewer line.
 - 8.3 Drain B-2 and Drain B-1 Interconnect. Engineer Brown/Schiebe Engineering has not finished the right-of-way plans.
- 9. Drain E Between La Palma Street and Stenger Street. Notice of Drain Right-of-Way still not completed.
- 10. Rules Revision. Not ready for Board action. The motion was made and seconded that the plat review fee be increased to \$200.00. Following a discussion, the motion carried. To clarify the Manager's authority to sign plats to streamline the plat approval process, the motion was made that the District's General Manager can sign final subdivision plats (mylar) that have previously been given preliminary approval if there have been no changes to the plat and all conditions have been satisfied, provided the final plat is signed at the following Board meeting. Following a discussion, the motion carried.

The Settlement Agreement, Plaintiffs' Motion to Dismiss Case, and a proposed Order Dismissing Case were presented to the Court at the March 5, 2024 Docket Control Conference.
